### • Traceability of fishery and aquaculture products in catering and retail

The Members of the European Parliament (MEPs) approved during the last EP Plenary session a non-legislative resolution asking a more strong traceability policy for all fishery products sold in EU restaurants and shops to avoid food fraud.

More specifically MEPs demanded the Commission to assess the benefits of setting up an EU-wide labelling system which would need to ensure transparency and credibility of the certification process and provide understandable, verifiable and accurate information.

Beside this, MEPs urged to put an end with the confusion caused by the current EU labelling requirements, based on UN Food and Agriculture Organisation (FAO) areas and sub-areas.

# • Public consultation for the Fitness Check of EU consumer and marketing law

The EC has launched a public consultation opened till 2<sup>nd</sup> September to gather contributions from citizens, organisations and public authorities on the Fitness Check of EU consumer and marketing law with the view to analyse whether these rules are still up to date and fit for purpose. The following six directives are subject to this Fitness Check:

- Unfair Contract Terms Directive 93/13/EEC
- Consumer Sales and Guarantees Directive 1999/44/EC
- Unfair Commercial Practices Directive 2005/29/EC
- Price Indication Directive 98/6/EC
- Misleading and Comparative Advertising Directive 2006/114/EC
- Injunctions Directive 2009/22/EC

## New fisheries partnership agreements

# EU-Mauritania

On 10<sup>th</sup> May the EP consented to the conclusion of this protocol. For Commissioner Vella this is the EU's biggest sustainable fisheries partnership agreement in financial terms and it is significant improvement compared to the previous protocol. For the EC this agreement may be considered an example to be followed for the negotiation of future agreements with other countries

#### EU-Liberia

On 10<sup>th</sup> May the EP consented to the conclusion of the agreement and its implementation protocol. According to the MEP Jaroslav Walesa, "the EU and mainly Spanish and French vessels targeting tuna will be allowed to fish in the waters of the Liberian Exclusive Economic Zone. In return, the EU will pay Liberia a financial contribution of €715000 for the first year, €650000 for the second, third and fourth year and €585000 for the fifth year".
