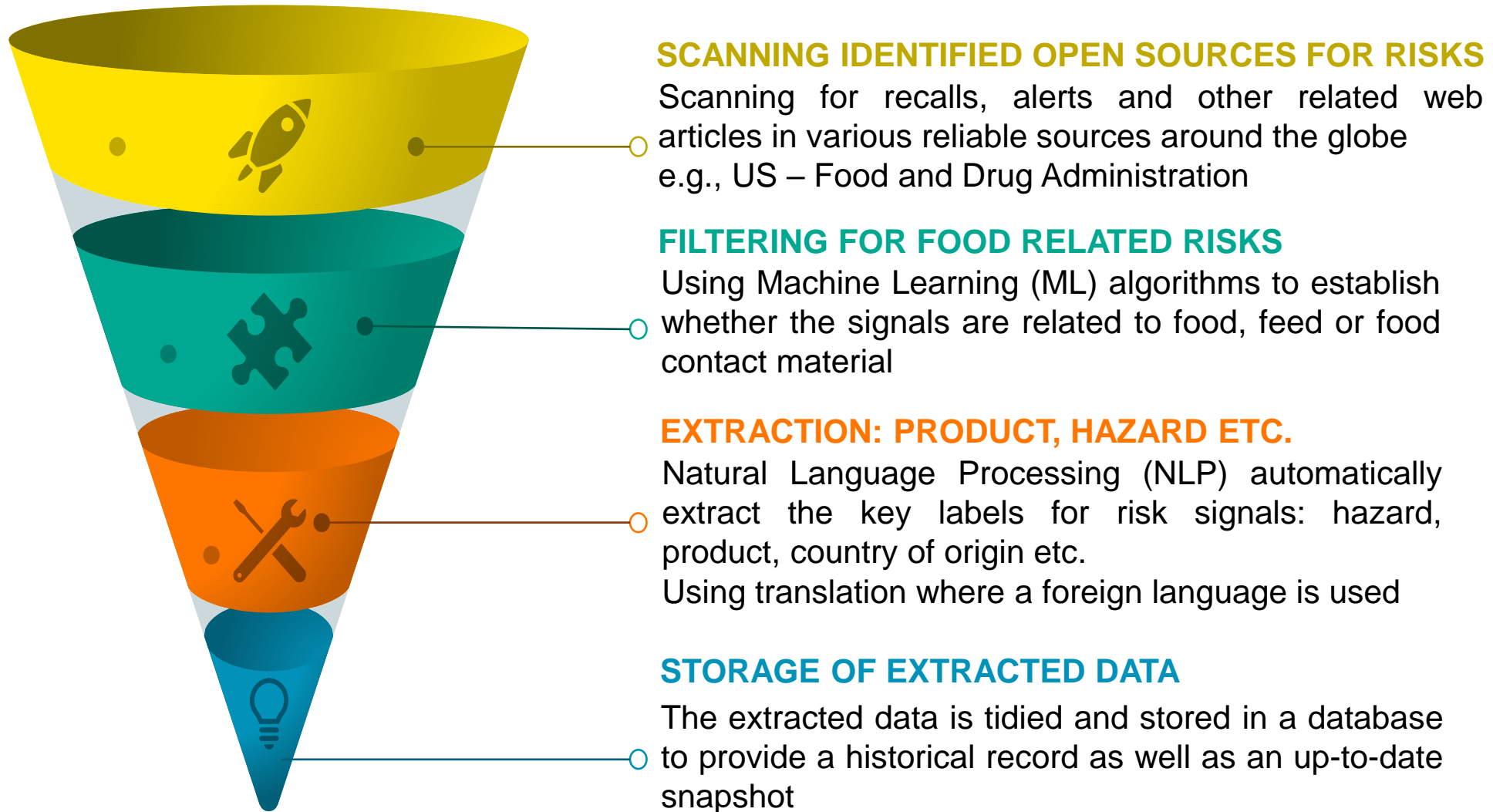

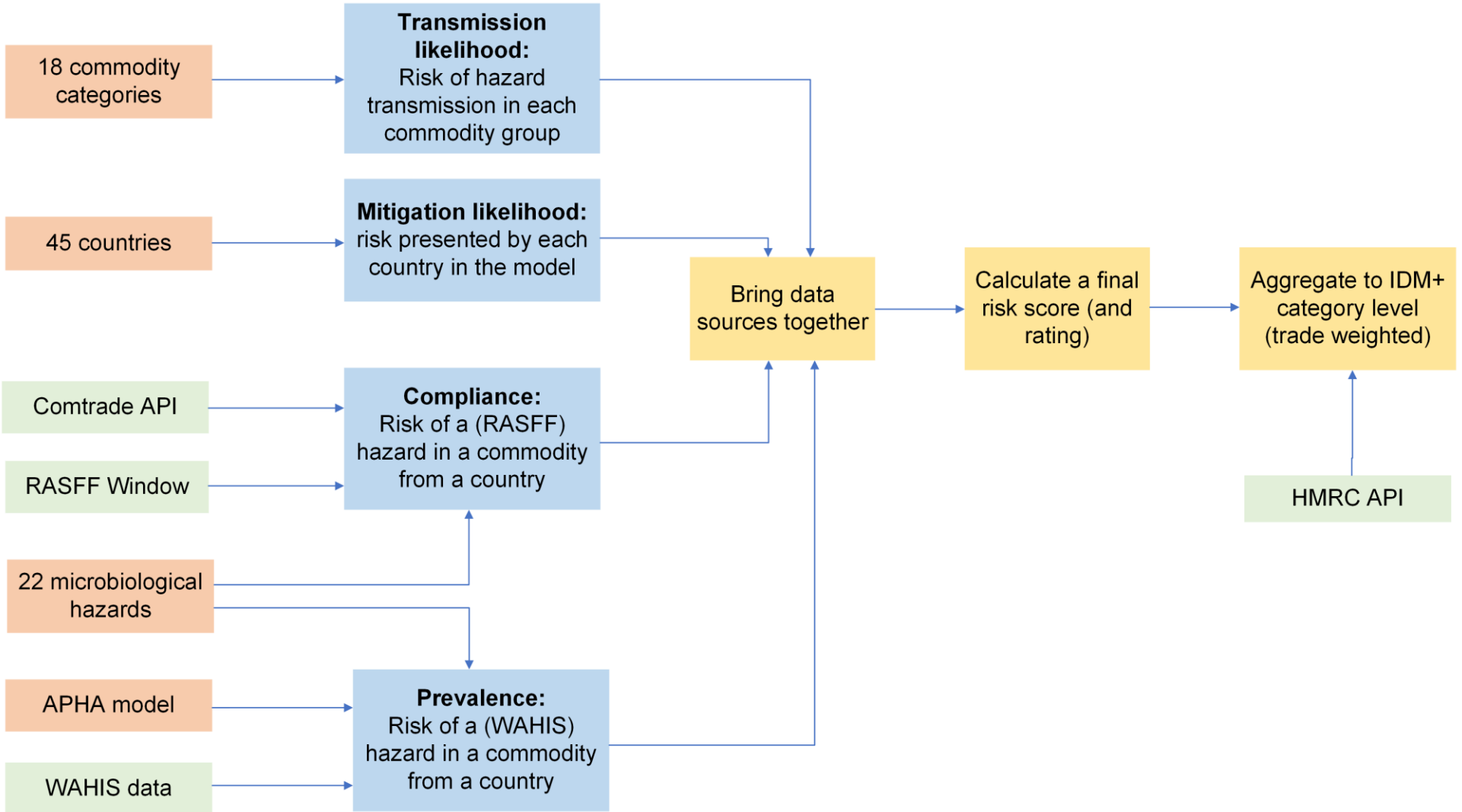

# Food Data Transparency Partnership overview

The Food Data Transparency Partnership (FDTP) is a long-term partnership between government, industry and experts that aims to drive positive change in the food system through better and more transparent food data.

It will focus first on consistent reporting on health and scope 3 greenhouse gas emissions.

For Defra, the initial focus of the partnership will be on improving the environmental sustainability of food and drink, focussed first on measuring scope 3 greenhouse gas emissions to meet our net zero targets.

For DHSC, the focus is on developing recommendations for a mutually agreed set of health metrics for large food and drink companies that support companies to report in a consistent way.

# The FDTP Eco Workstream

## Aims:

1. To ensure **greenhouse gas (GHG) impact reporting** for food and drink companies is **consistent, accurate and fair**
2. To ensure **consumer information** on the environmental impacts of food is **consistent, clear and accurate**
3. To enable government, civil society, investors and the food industry to **compare performance** on GHG emissions fairly, and to ensure **good practice is recognised and supported.**
4. To effectively **collaborate** across government, the food and drink industry and wider experts, generating **shared solutions** to measuring and communicating GHG impact

# What will the eco workstream deliver?

In the first phase, the eco workstream will deliver the following:

- ✓ **A standardised methodology and data sources** for measuring greenhouse gas emissions of food and drink at a company level (scope 3 emissions) and a product level
- ✓ **A consistent reporting mechanism** for large food and drink companies to report scope 3 GHG emissions at a company level.
- ✓ **A mandatory methodology** for voluntary food and drink eco-labels.

**The FDTP eco working group** aims to develop proposals on the above for publication **by the end of 2023.**

- Co-chaired by **Judith Batchelar OBE** (Environment Agency deputy chair and former Director of Brand, Sainsbury's) and **Karen Lepper** (Deputy Director for Food Data Standards and Sustainability, Defra).
- The group includes around **20 members from industry and civil society** with relevant practical and technical experience.

# Eco workstream progress so far:



**On company reporting:** we have agreed that to achieve a consistent reporting mechanism, we will align with future sector agnostic reporting - the forthcoming ISSB Climate-related disclosure standards are going to be assessed for adoption in the UK.



**On a standardised methodology for company level GHG measurement:** we have agreed to support WRAP in translating the GHG Protocol Scope 3 standard into guidance for the food and drink sector.



**On data:** we have identified key barriers to gathering, sharing and reporting good quality data. These include the availability and quality of farm data, quality of emission factor data and movement of data through the system. We have also explored alignment with international initiatives for product level carbon accounting and the need for additional guidance on methodologies.



**On eco-labelling:** we are closely following the progress made by IGD and the approach taken by other eco-labelling schemes. We have planned in-depth discussions at upcoming Eco Working Group meetings on product-level information.

## FDTP partnership approach

- The partnership will actively engage with organisations across the food and drink sector to shape proposals, and all measures will be formally consulted on.
- The FDTP will seek to build on initiatives that are already underway.
- **Technical working groups** will bring together subject matter expertise from across industry and civil society.
- The **Food and Drink Sector Council** will provide strategic advice to the partnership.
- Industry views on operational issues will be provided via a **Design Partnership Group**.
- Organisations that are not members of these groups will have the opportunity to feed in views to the partnership through an ongoing programme of engagement.

## Meetings to date

- The FDTP was discussed at the February and May meetings of the **Food and Drink Sector Council**.
- The first meeting of the **Design Partnership Group** took place in February and the second on 17th April.
- The first meeting of the **Eco Working Group** took place in March. Meetings will continue on a monthly basis throughout 2023.
- The first meeting of the **Data Working Group** took place on 1st June.



# Health Working Group

Transparent and consistent data will help drive the food system to be healthier.

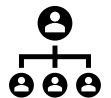
- ✓ To develop recommendations for a mutually agreed set of health metrics for large food and drink companies
