




This map represents all Active Basic, Comprehensive, Prospective, and Completed FIPs currently listed on FisheryProgress.

BALANCING IMPACT AND PRACTICALITY




It is tricky to strike a balance between urgency due to the nature of the issue and incremental implementation due to the financial and human costs this policy will add on FIPs.



POLICY | RISK CRITERIA


- 1. There is **at-sea transshipment** of product and/or fishers among large vessels in the FIP.
- 2. The FIP has one or more vessels with a **significant foreign migrant workforce** (defined as 25% or more of fishers are not citizens of the vessel's flag state).
- 3. The FIP has one or more vessels where **fishers are not allowed on shore at least once every 90 days**.
- 4. The fishery has a **known instance of forced labor, child labor, or human trafficking abuse** within the past four years.
- 5. The FIP **doesn't have enough information** to determine if it meets any of the above criteria.

Summary

FisheryProgress launched its Human Rights and Social Responsibility policy on May 12, 2021. There is a phased timeline for FIPs currently reporting on FisheryProgress to meet the new requirements:

- First regular reporting deadline after Nov. 1, 2021: FIPs must sign the FisheryProgress Human Rights Code of Conduct and complete the Selfevaluation of Risk Criteria (Requirements 1.1 and 1.5 in the policy).
- First regular reporting deadline after May 1, 2022: FIPs must provide information about the vessels or fishers in the FIP, undertake efforts to make
 fishers aware of their rights, and demonstrate there is a grievance mechanism available to all fishers in the FIP (Requirements 1.2, 1.3, and 1.4 in the
 policy).
- 12 months after submitting the Self-evaluation of Risk Criteria (for most FIPs, around/after Nov. 1, 2022): If a FIP meets one or more criteria for
 increased risk of forced labor and human trafficking, it must conduct a risk assessment and complete a social workplan to address red-scoring
 indicators (Requirements 2.1 and 2.2 in the policy).



- **1.4** Demonstrate there is a grievance mechanism available to all fishers in the FIP
- 1.5 Complete a self-evaluation against the FisheryProgress criteria for increased risk of forced labor and human trafficking

Component 2: Additional Requirements for FIPs that meet the risk criteria

- **2.1** Complete a risk assessment using the Social Responsibility Assessment (SRA)
- **2.2** Create a social workplan to address all red indicators in the risk assessment
- **2.3** Report publicly on action progress and update indicator scores
